Ellie's Story from Gala

Ellie's Story as told by a Legacy staff member and Ellie, herself.

My name is Ellie Holbrook, I am 18 years old. Over the last couple years I have battled many hardships, including depression. These events started leading me down the wrong path. I was stuck in a cycle of feeling worthless, and constantly searching for something that would fulfill me – some validation. So when I met my daughter's father, I was excited at the prospect of a new relationship, one that would give me everything I had been searching for. I soon found out that he was a master of lies and deception. What began as thoughtfulness soon turned to abuse. I was smart enough to make my exit from that relationship, only to return back to him months later. The Devil is strategic in making us believe we need someone, when that person is actually going to hurt us. The second time I realized just as quickly as the first that being with him was not safe. 2 weeks after we broke up, I found myself staring at a positive pregnancy test in the school bathroom. As I stared at those two lines, a multitude of feelings arose in me.

Ellie came to Legacy lost and broken and looking to justify the hurt that had happened to her. She was excited to find out that she was pregnant, but terrified at the same time. She knew that she was going to be doing this alone, wondering if she might have some support from her family. She was scared to tell them but found the courage the same night that she had come in. Her parent's reaction was not one that she expected. Instead of responding out of anger they responded with love and compassion. They prayed with her that very moment.

I was not expecting, or deserving of the love and support my family gave me when I told them I was pregnant. Or the support they have given me since then. Having to hide my pregnancy every day I went to school took a toll on me, but Legacy offered a community where I didn't have to hide. I struggled through my pregnancy more than what I let on, from the mental aspect. But I had and still have an overwhelming amount of support which I am eternally grateful for.

Ellie actively participated in parenting classes and attended Mommy Groups at Legacy. She made connections with other clients during those gatherings and she hopes that she can come alongside another teen mom to help her see that there is hope. Ellie had a baby girl in August of 2023 and named her Caroline.

The day my daughter was born was one of the greatest days, it was full of almost every emotion! Meeting her was the coolest experience of my life, and it made me have a deeper appreciation for Gods creation. I am not anything special, I have strayed from the Lord time and time again, yet He never left my side. Through everything I know Gods purpose for me is to be prosperous to those who are where I once was.

Ellie has grown so much! She has reconnected with God and her family. God has brought her and her dad closer together than they have ever been. Caroline is a happy beautiful baby.

She brings so much joy to her family and Legacy staff.

Even as I grow into my new role as a mother, God meets me where I am. He's always met me in the darkness, all I had to do was look to the light of my Savior. For anyone reading this who might feel hopeless, or find themselves asking God why, look up to the Lord, for in Him you will be set free.
